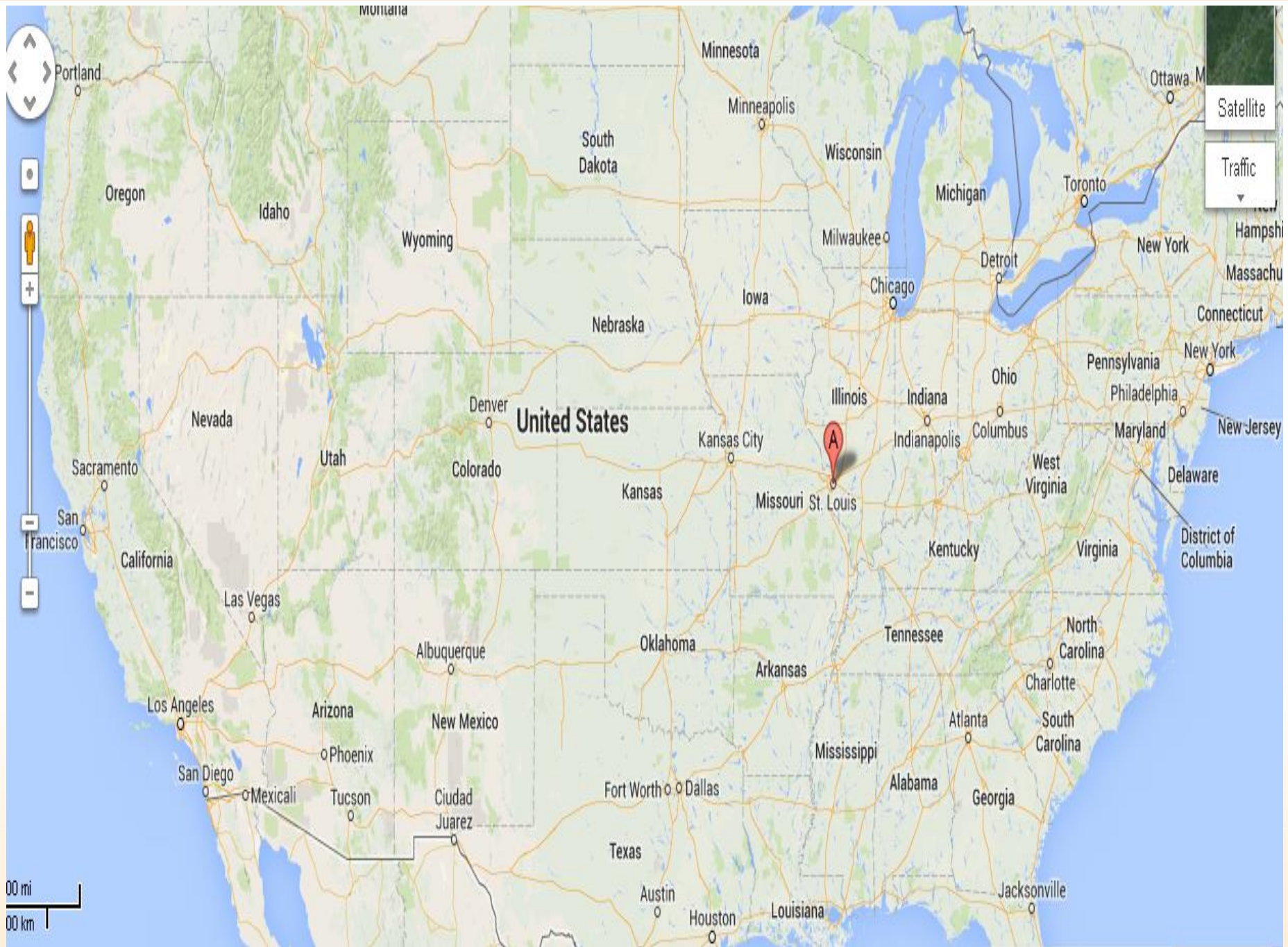

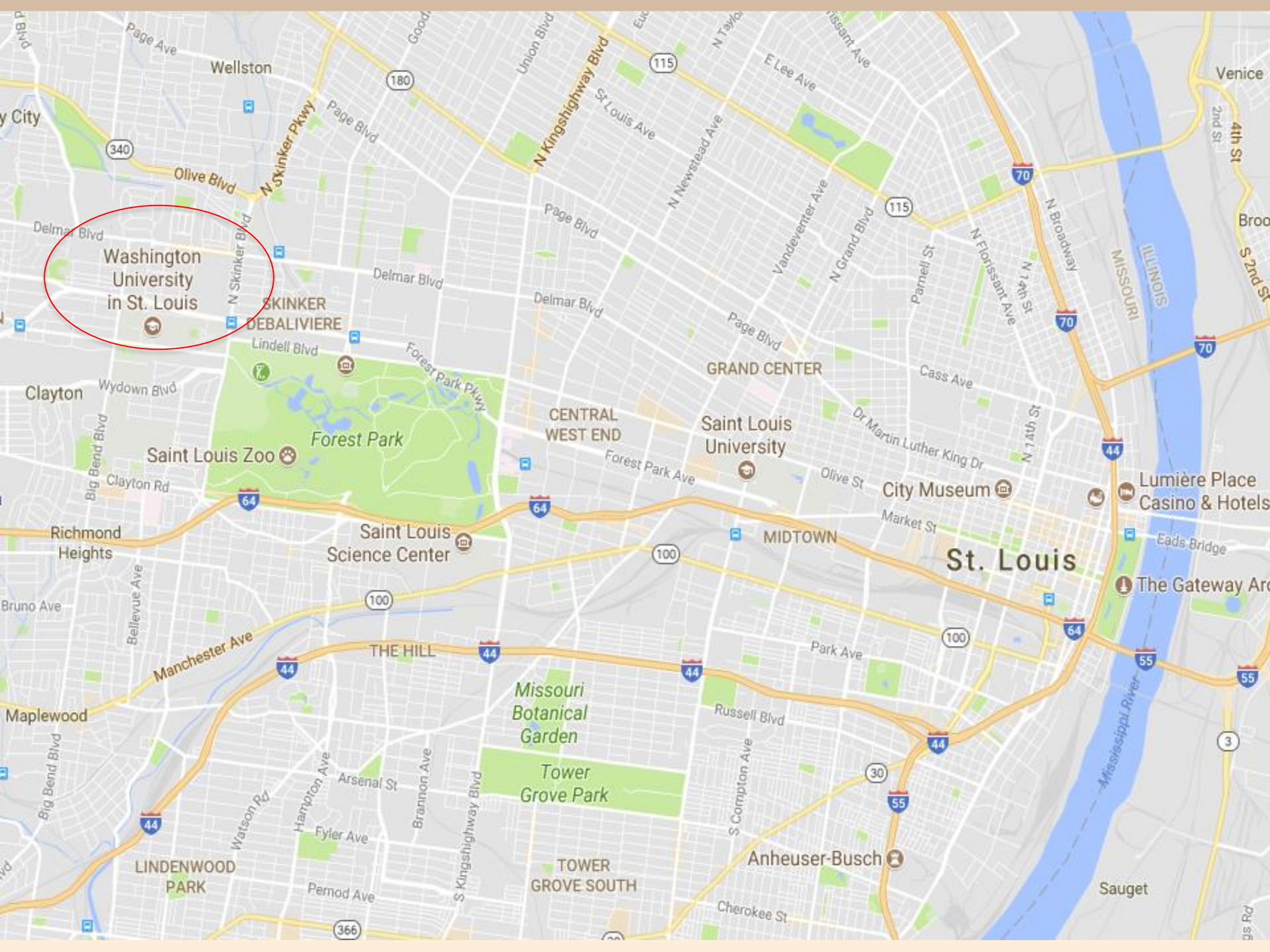

- Washington University's students and faculty come from more than 100 countries around the world.

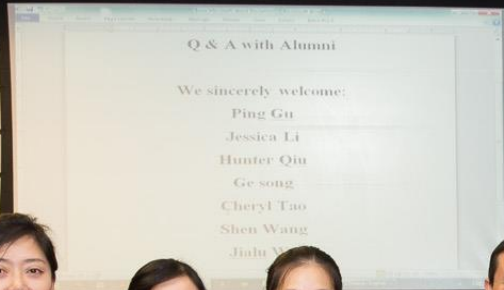

## Three LLM Degrees

## **Intensive Legal English Class on Campus (ILEP Summer program)**

- Intensive Introduction to Common Law Reasoning, Case Reading, Written Legal Communication
- 4 weeks ( from the first week of July)
- Taught by ESL professionals
- Enrollment fee of about \$ 7,000 will be reimbursed as tuition remission

## Admission Requirements



- U.S. Law LL.M. candidates must have earned or will earn a first law degree (undergraduate or master) from their home jurisdiction.
- TOEFL 90 or more (Internet-based and Home-edition for 2021), 6.5 or more in IELTS, or Duolingo at least 115 . (The TOEFL code for the law school is 6929-03).

## **2-Year LL.M. Program**

**(for academically excellent students with TOEFL scores of around 80)**

### **First year**

**Summer: 6 week Intensive Legal English class (ILEP)**

**2-Week Orientation together with 1-year LL.M**

**Fall and Spring:**

**Intensive Legal English classes (10 hrs per week)**

**Two Content Classes- Introduction to US. Legal Methods**

**- Introduction to ADR or other JD  
class**

**together with 1-year LL.M students plus visits to courts  
and other extracurricular events**

**The second year is designed as a regular 1-year LL.M.**

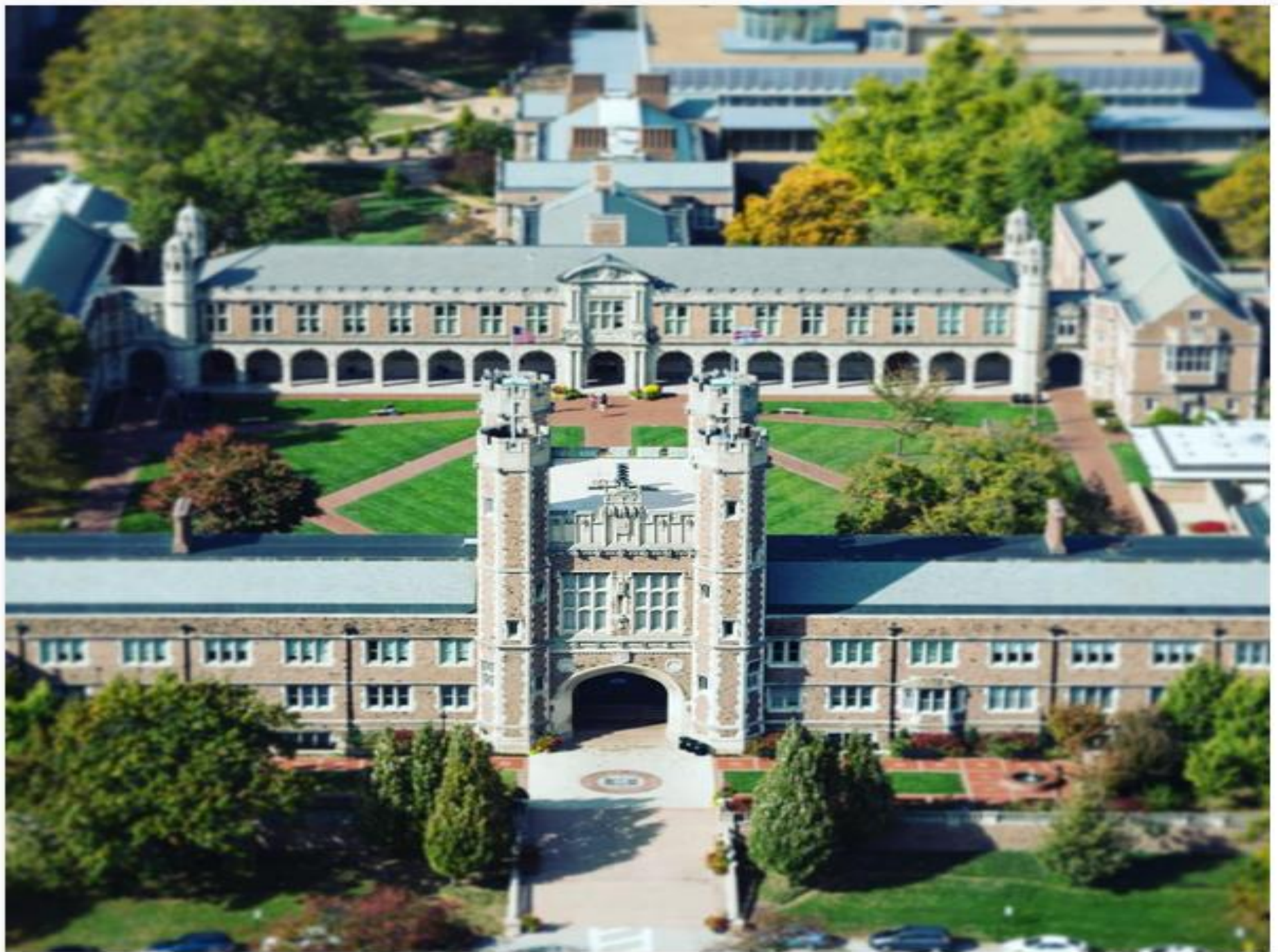

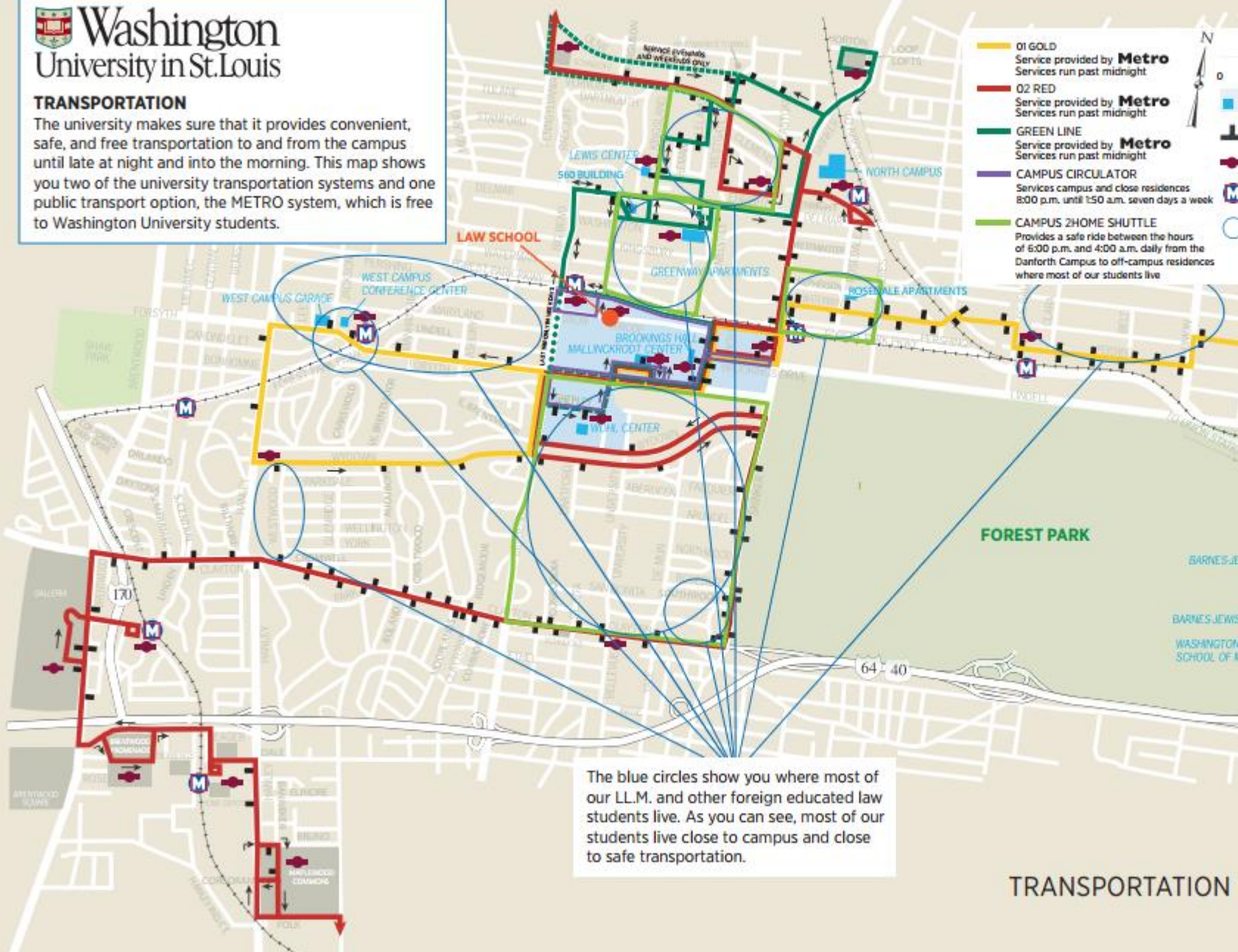






## TRANSPORTATION

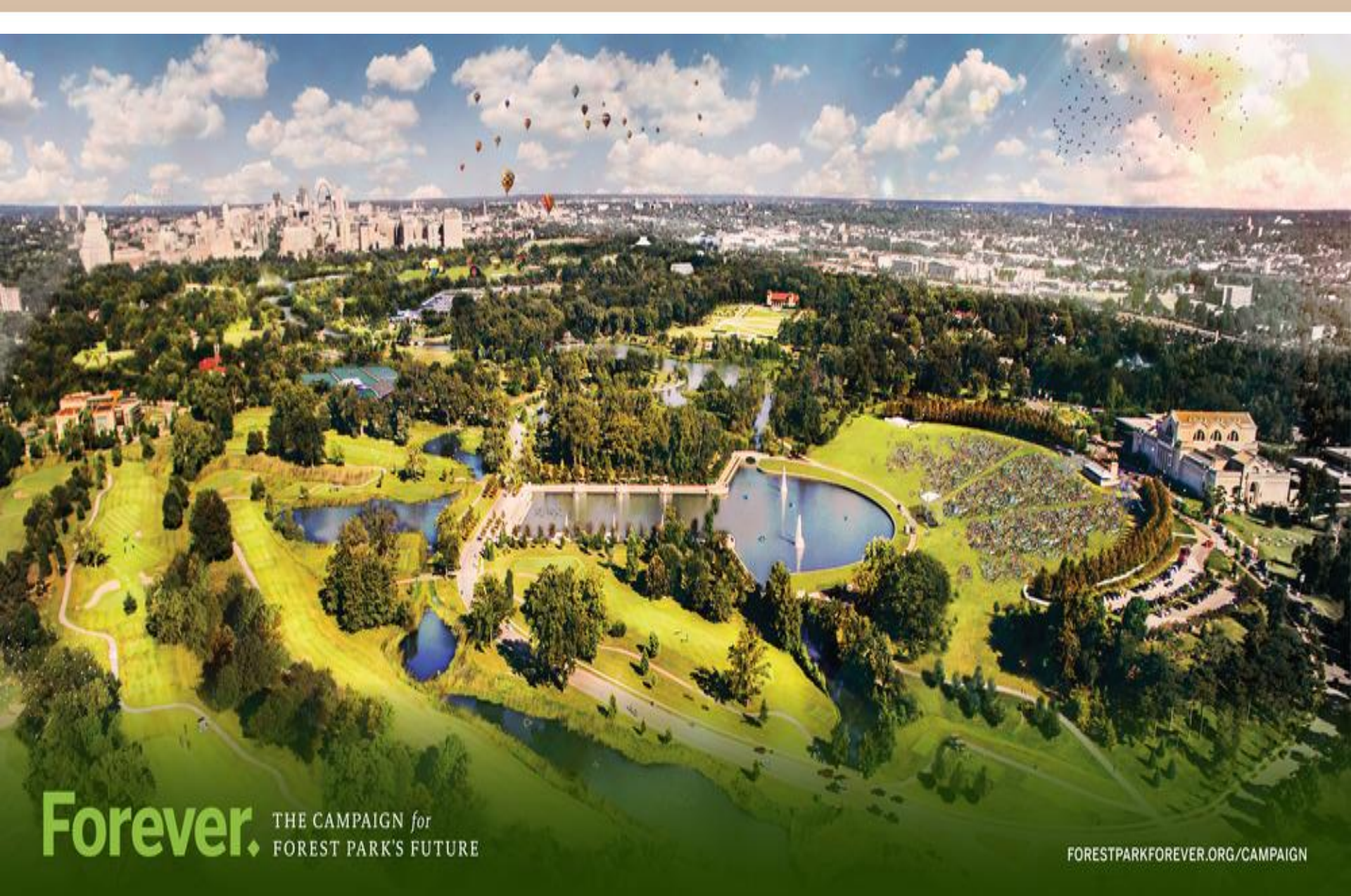
